### Non-compliance with the accessibility regulations

# Website wide issues

### Headings

Unfortunately our website does not support a headings map at this time. We will correct this when we have the technology to assist.

### Insufficient alt text

Some images contain text which cannot be read by assistive technology, such as screen readers. Any relevant text is included in the image's alt-text, which is visible to assistive technology. ### **Image backgrounds**

### **Content specific issues**

### **Overlapping and cropped text in tables**

Tables may include overlapping or cropped text when viewed through a viewport width of 320 pixels or less: This affects smaller smartphones such as the iPhone SE. This is not compliant with WCAG guideline 1.4.10. We are investigating solutions for this.

### Content that is not within the scope of the accessibility regulations

This section covers issues that we do not need to fix right now. The law calls these exemptions.

### **Disproportionate burden**

Compatibility with all aspects of the Web Content Accessibility Guidelines (WCAG) version 2.1 AA is not possible at this time due as our website needs to be upgraded. We hope that this can be done within a reasonable timeframe, we will update you here when we have more information.
